THE POSITION

The Trade Council is seeking two Commercial Advisors to join the team. You will play a key role in promoting Danish companies by identifying market opportunities, developing business strategies, improving framework conditions, and being responsible for maturing project opportunities by utilizing and developing a network of relevant stakeholders in Spain. One particular focus area will be to identify opportunities within the Spanish recovery plan.

You will work for The Trade Council under the Danish Ministry of Foreign Affairs and be part of a dynamic team of seven trade advisors assisting Danish companies seeking commercial opportunities in Spain. Your main tasks will include, but are not limited to, the following:

- Helping Danish businesses to assess markets in Spain, and assist them in developing effective entry strategies.
- Generate Danish export opportunities in the South Europe region.
- Lead generation and outreach to Denmark- and Spain-based clients.
- Research and prepare digital content, including Spain market insights and sectorspecific analysis for Danish companies looking to export to Spain.
- Feasibility Studies, Fact Finding and Partner Search & Development.
- Risk Advisory and Due Diligence.
- Government Relations & Public Affairs.

- Experience from and network within Energy & Environment, Food & Agriculture and/or the Tech sector in Spain will be an advantage.
- Solid network and good understanding of market dynamics in Spain.
- Proven experience from working with both governmental stakeholders and the private sector.
- Analytical mind-set and ability to think creatively and take a proactive role in achieving work goals and objectives.
- Excellent communication skills, including fluency in English and Spanish. Knowledge of Danish would be an asset.
- Result-oriented, flexible, and open-minded team player.
